Dear Ron Lalonde,

I am writing in response to your letter of April 29, 2021, addressed to Chantalle Aubertin, Press Secretary to the Honourable Catherine McKenna, Minister of Infrastructure and Communities, regarding the Active Transportation Strategy. Please accept my apologies for the delay in responding.

As you note in your correspondence, on March 12, 2021, Minister McKenna and Parliamentary Secretary Andy Fillmore announced a \$400-million fund over five years for active transportation that will help build new and expanded networks of pathways, bike lanes, trails and pedestrian bridges. This is the first federal fund dedicated to building active transportation throughout Canada, and part of the Government of Canada's plan to create one million jobs, fight climate change, and build a more sustainable and resilient economy. Investing in pathways and trails for cycling, walking, hybrid e-bikes and scooters, and wheelchairs gives everyone the opportunity to get to work, school, parks or public transit in a safe and convenient way.

The Active Transportation Fund is part of an eight-year, \$14.9-billion public transit investment outlined by Prime Minister Trudeau on February 10, 2021. It will support communities as they build vibrant neighborhoods where people can live, work and play. The Fund will also help Canadians living in rural communities and places without active transportation options to unlock the potential in their communities.

This funding builds on existing federal initiatives that support active transportation. Recognizing the environmental and public health benefits of active transportation, the Government of Canada has adjusted the Investing in Canada Infrastructure Program so that provinces and territories can use federal funding to act quickly on a wider range of more pandemic-resilient infrastructure projects, such as active transportation projects. Under the new COVID-19 Resilience stream, active transportation infrastructure, such as parks, trails, foot bridges, bike lanes and multi-use paths are eligible for a significantly larger federal cost share.

As well, the \$31-million Canada Healthy Communities Initiative is supporting community-led solutions that respond to needs arising from COVID-19. Smaller-scale projects are eligible for funding under three main themes: creating safe and vibrant public spaces, improving mobility options, and digital solutions. Active transportation infrastructure, such as multi-modal paths, are eligible projects.

In addition to new funding, Minister McKenna and Parliamentary Secretary Fillmore launched stakeholder engagements for Canada's first Active Transportation Strategy on March 12, 2021. Since that time, they have met with provinces and territories, municipalities, Indigenous organizations, non-government organizations, academics and business groups from across the country to seek their views on how to best deliver active transportation infrastructure in Canadian communities.
